AN EXECUTIVE ORDER RE – ORGANIZING THE COMPOSITION OF THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) OF THE LOCAL GOVERNMENT UNIT OF BONGABON, NUEVA ECIJA IN ACCORDANCE WITH THE CIVIL SERVICE COMMISSION MEMORANDUM CIRCULAR 24 S. 2017 AND NAMING THE NEW MEMBERS HEREOF.

WHEREAS, Pursuant to the provision of Section 3, Article IX-B of the 1987 Philippine Constitution, the Civil Service Commission, as the human resource agency of the Government shall establish a career service and adopt measures to promote morale, efficiency, integrity, responsiveness, progressiveness and courtesy in the civil service. It shall strengthen the merits and rewards system, integrate all human resources development programs for all levels and ranks, and institutionalize a management climate conducive to public accountability.

WHEREAS, Section 80(b) of the Local Government Code of 1991 (RA 7160), mandates that there shall be a Personnel Selection Board to assist the Local Chief Executive in the judicious and objective selection of personnel for employment as well as promotion, and in the formulation of such policies as would contribute to employee welfare. This shall be done in every province, city or municipality.

WHEREAS, the principle of equal opportunity for all qualified and meritorious applicants is institutionalized and gives substance to the true meaning of equal opportunity in democracy;

WHEREAS, this method of selection has a way of strengthening the capacity of the government to recruit and provide service to its constituency;

NOW THEREFORE, I RICARDO I. PADILLA, by virtue of the powers vested in me by law, do hereby reorganize the HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD (HRMPSB) and naming the members hereof;


