AN EXECUTIVE ORDER, ESTABLISHING SPECIAL COMMITTEE FOR THE IMPROVEMENT OF THE GENERAL OPERATIONS OF BONGABON PUBLIC MARKET AND SPECIFYING THEIR SPECIAL TASK THEREOF:

FOR THE PURPOSE OF THIS EXECUTIVE ORDER, the following are the Composition of the Special Committee to be named as Special Task Force Market (STFM), to wit;

TASKS:

- A. The Chairman shall be the over-all in charge for the planning and implementation of various measures regarding the operation of the Public Market.
- B. The Co-Chairman shall be the hands on in charge for the supervision of the general operation of the Public Market.
- C. SB Member, Chair, Committee on Trade and Industry (Melodie G. Dela Cruz) assist in formulating legislative agenda necessary for the improvement of the operation of the Public Market, like necessary amendments of Market Code, traffic and parking management and other necessary legislative measures.

- D. The Administrator (Mr. Prudencio J. Elegado) assist the Chairman and Co-Chairman in the planning and implementation of various measures for the improvement of the operation of the Public Market.
- E. Municipal Treasurer (Ana Liza M. Cruz) monitor the legalities of constracts given to the occupants of the different market stalls in the Public Market.
 - -assure that all necessary business permits, licenses and fees are collected in coordination with BPLO.
 - -make a comprehensive report/list as to the ownership of stalls, collections of fees and other financial matters, involving the operation of Public Market.
- F. Business Permits and Licensing Office(BPLO) (Rowena Cabural) make a thorough accounting of operational and non-operational stalls/business shops in the Public Market.
 - -ensure that all business establishments/stalls operating in the area are business permits compliance including provisions of necessary requirements like fire safety, waste management and others.
 - -imposed the "NO COMPLETE REQUIREMENT NO PERMIT TO OPERATE POLICY".
- G. Engineering Office (Engr. Ferdinand Arucan) make thorough inspection as to the safety of the different buildings and stalls in the Public Market.
 - -ensure the maintenance of the different infrastructures inside the Public Market like interior roads, canals, toilets and others.
 - -ensure the availability of water and energy supply in the entire market by doing a regular checkup on the electricity and water lines supplying the entire Public Market.
- H. MENRO (DR. Gil Dinglasan) maintain the regular hauling of waste/garbage materials in the entire Public Market.
 - -supervise the different stalls as to their compliance to garbage bin requirements, waste segregation practices and other environmental concerns.
- PNP-Bongabon assist in the maintenance of the orderliness in the Public Market as to traffic and parking management in the Public Market.
 - -help execute parking and traffic management policy as may be imposed through Executive Orders and Ordinances.
 - -imposed other rules and laws as maybe implemented through Special Orders like Covid19 related situationers.
- J. BFP-Bongabon assist the PNP in maintaining the orderliness in the vicinity of Public Market.
 - -assist the Market Supervisor in the cleaning of the area as needed through available fire trucks.
 - -ensure the availability of needed support in times of emergencies, like accidents and occurrence of accidental fire which may result to damage and danger to people and properties.
- K. DTI-Bongabon assist the Public Market Supervisor in various trade and industry policies in the operation of Public Market.
 - -help to monitor prevailing prices of commodities available in the market and report unscrupulous practices of traders and customers as well.

For the purpose of monitoring the progress of the activities of the special task force, the Committee through the Co-Chairman shall submit progress reports monthly or as often as necessary.

This Executive Order shall take effect immediately.
